From the West: Drive East toward Phoenix on I-10 and exit on State Route 85 South to Gila Bend. After crossing the Gila River bridge (about 3 miles) take the first road West into Robbins Butte Wildlife Area.

From the South: From Gila Bend on State Route 85 drive North to the turnoff to Robbins Butte Wildlife Area (about 4 miles North of the Lewis Prison complex). Turn west into the area.

On December 7/8, 2013, **these grounds will be used only for the use of live/dead birds for simulated hunting dog activities.” No actual hunting situations!**

I am aware that hunting dog activities (where live guns and ammo are used) could be a hazardous activity and I am **voluntarily** participating or watching these activities with knowledge and appreciation of the danger involved and hereby agree to accept any and all risks of property damage, injury, or death. **INITIAL**_____.

As **LAWFUL CONSIDERATION** for being permitted to participate in these activities and use these facilities, I agree that I, my heirs, distributees, guardians, legal representatives, and assigns **WILL NOT MAKE A CLAIM AGAINST, SUE, ATTACH THE PROPERTY OF, OR PROSECUTE CSHRC, PROPERTY OWNERS, AGENTS AND AFFILIATED ORGANIZATIONS FOR INJURY TO MY PERSON OR DAMAGE TO MY PROPERTY RESULTING FROM THE PASSIVE OR ACTIVE NEGLIGENCE OR OTHER ACTS, HOWEVER CAUSED, by an agent, as a result of my participation in any of the activities conducted on the grounds listed above.**
